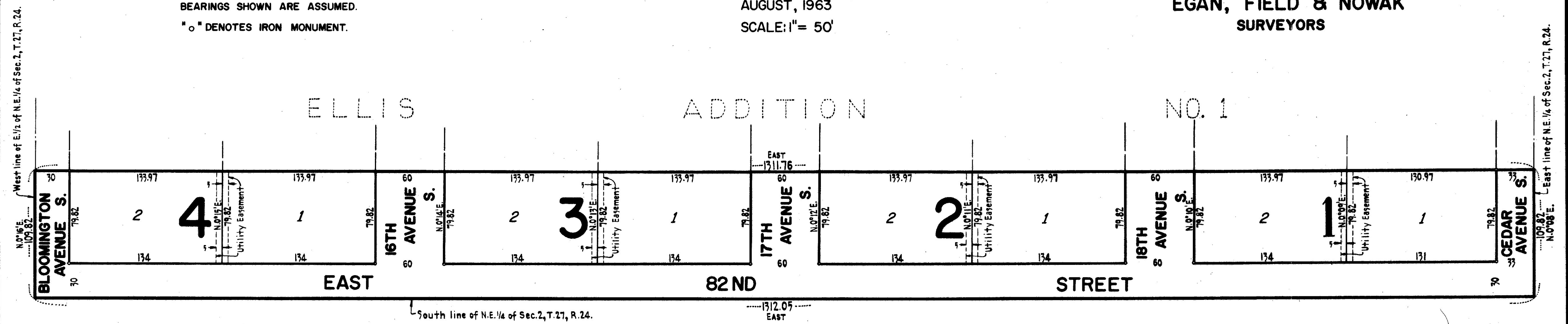


ADELMANN ADDITION

"o" DENOTES IRON MONUMENT.






GREGG'S SUBDIVISION






