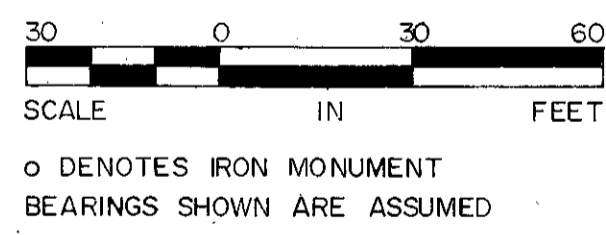
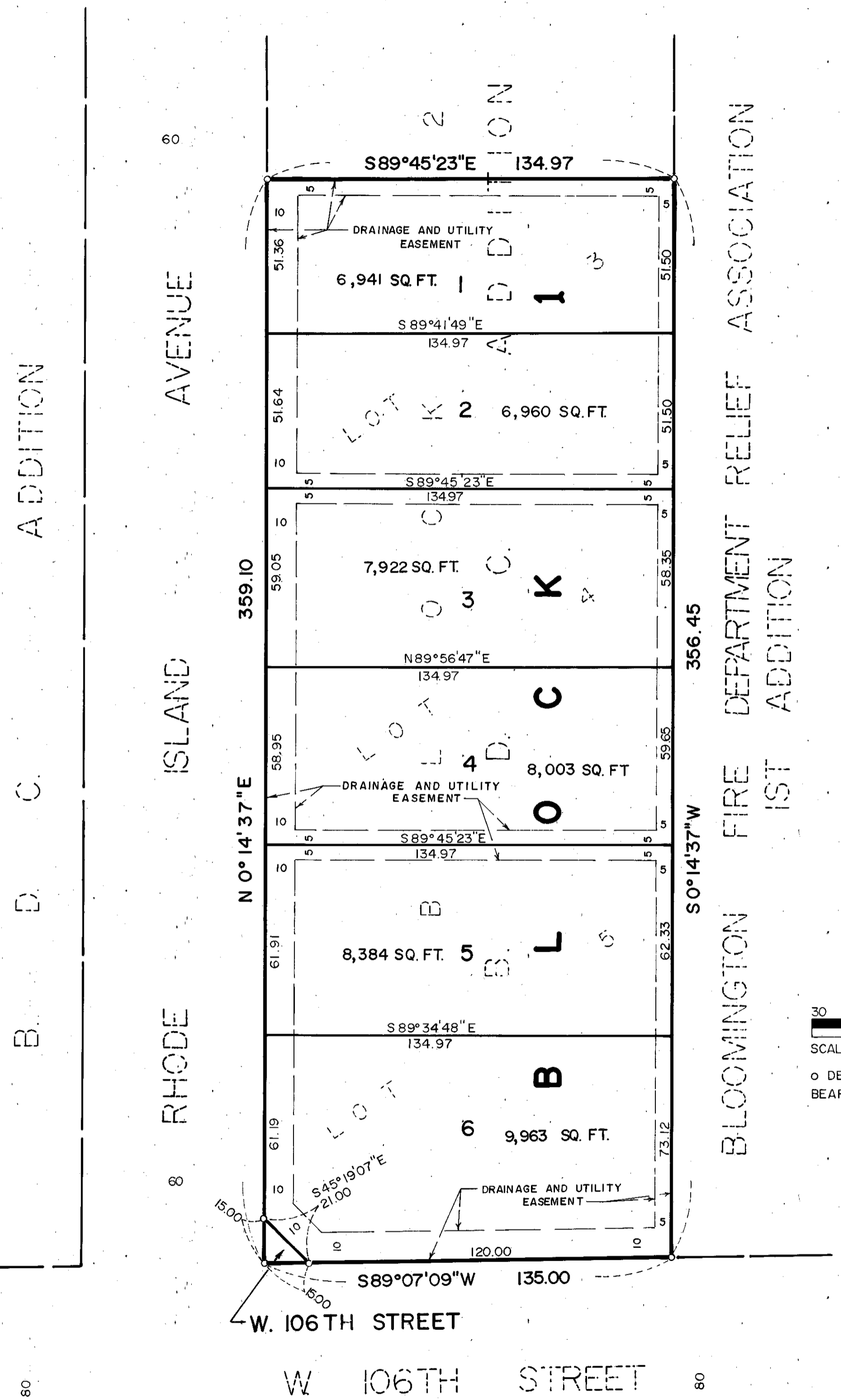

Lots 3, 4 and 5, Block 2, B. D. C. Addition, according to the recorded plat thereof.

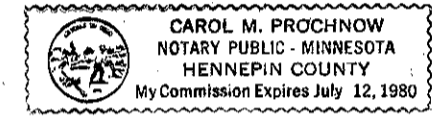

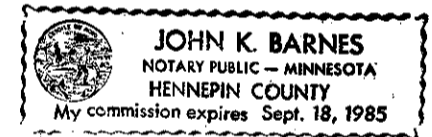
