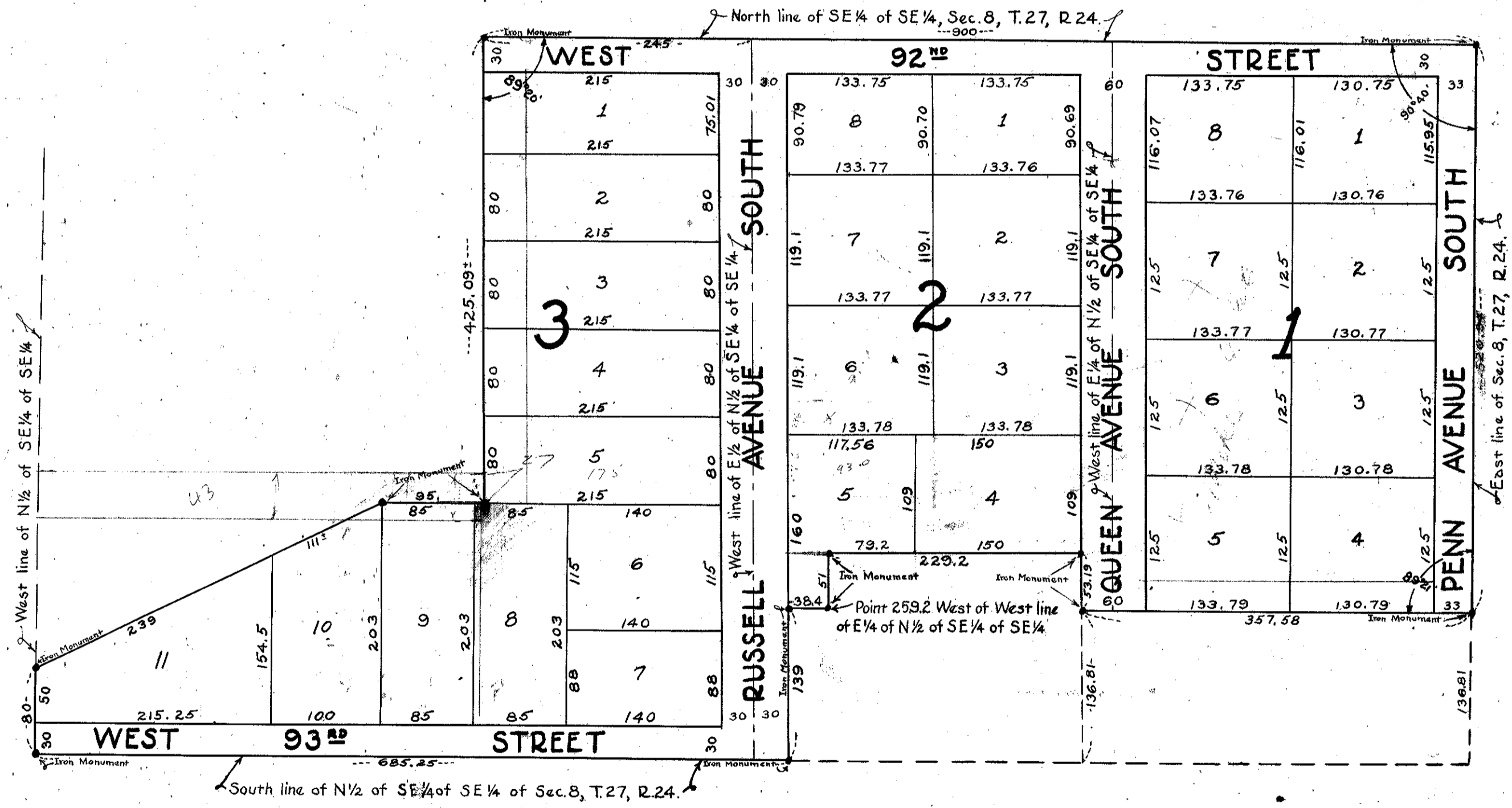


BART'S ADDITION



KNOW ALL MEN BY THESE PRESENTS: That I Harry Barthel, single owner and proprietor and Richfield State Bank, a Minnesota Corporation, Mortgagee, of the following described property situate in the County of Hennepin, State of Minnesota to wit: That part of the North One Half (N $\frac{1}{2}$) of the Southeast Quarter (SE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) of Section Eight (8), Township Twenty Seven (27), Range Twenty Four (24), described as follows: Beginning at the Northeast corner of said North One Half (N $\frac{1}{2}$) thence West along the North line thereof a distance of Nine Hundred (900) feet more or less to a point which is Two Hundred Forty Five (245) feet West of the West line of the East One Half (E $\frac{1}{2}$) of said North One Half (N $\frac{1}{2}$), thence South parallel with the West line of said East One Half (E $\frac{1}{2}$) of said North One Half (N $\frac{1}{2}$) Four Hundred Twenty Five (425.09) feet more or less to a point which is Two Hundred Thirty Three (233) feet North of the South line of said North One Half (N $\frac{1}{2}$), thence West parallel with said South line of said North One Half (N $\frac{1}{2}$) a distance of Ninety Five (95) feet, thence Southwesterly to a point in the West line of said North One Half (N $\frac{1}{2}$) of the Southeast Quarter (SE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) Eighty (80) feet South along said West line of the North One Half (N $\frac{1}{2}$) of the Southeast Quarter (SE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) Eighty (80) feet to the Southeast corner thereof, thence East along the South line of said North One Half (N $\frac{1}{2}$) a distance of Six Hundred Eighty Five (685.25) feet more or less to a point which is Thirty (30) feet East of the Southwest corner of the East One Half (E $\frac{1}{2}$) of said North One Half (N $\frac{1}{2}$), thence North parallel with the West line of said East One Half (E $\frac{1}{2}$) a distance of One Hundred Thirty Nine (139) feet, thence East parallel with the South line of said North One Half (N $\frac{1}{2}$) a distance of Thirty Eight and Four Tenths (38.4) feet more or less to a point which is Two Hundred Fifty Nine and Two Tenths (259.2) feet West of the West line of the East One Fourth (E $\frac{1}{4}$) of said North One Half (N $\frac{1}{2}$) of the Southeast Quarter (SE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) of said East One Fourth (E $\frac{1}{4}$) Fifty One (51) feet, thence East parallel with the South line of said North One Half (N $\frac{1}{2}$) Two Hundred Twenty Nine and Two Tenths (229.2) feet to a point which is Thirty (30) feet West of the West line of said East One Fourth (E $\frac{1}{4}$) Fifty Three and Nineteen Hundredths (53.19) feet North of the South line of said North One Half (N $\frac{1}{2}$) thence East parallel with the South line of said North One Half (N $\frac{1}{2}$) Three Hundred Fifty Seven and Fifty Eight Hundredths (357.58) feet more or less to a point in the East line of said Section Eight (8) thence North along said East line, Five Hundred Twenty and Ninety Four Hundredths (520.94) feet more or less to the point of beginning, have caused the same to be surveyed and platted as BART'S ADDITION and do hereby donate and dedicate to the public for the public use forever the streets and avenues as shown on the annexed plat.
