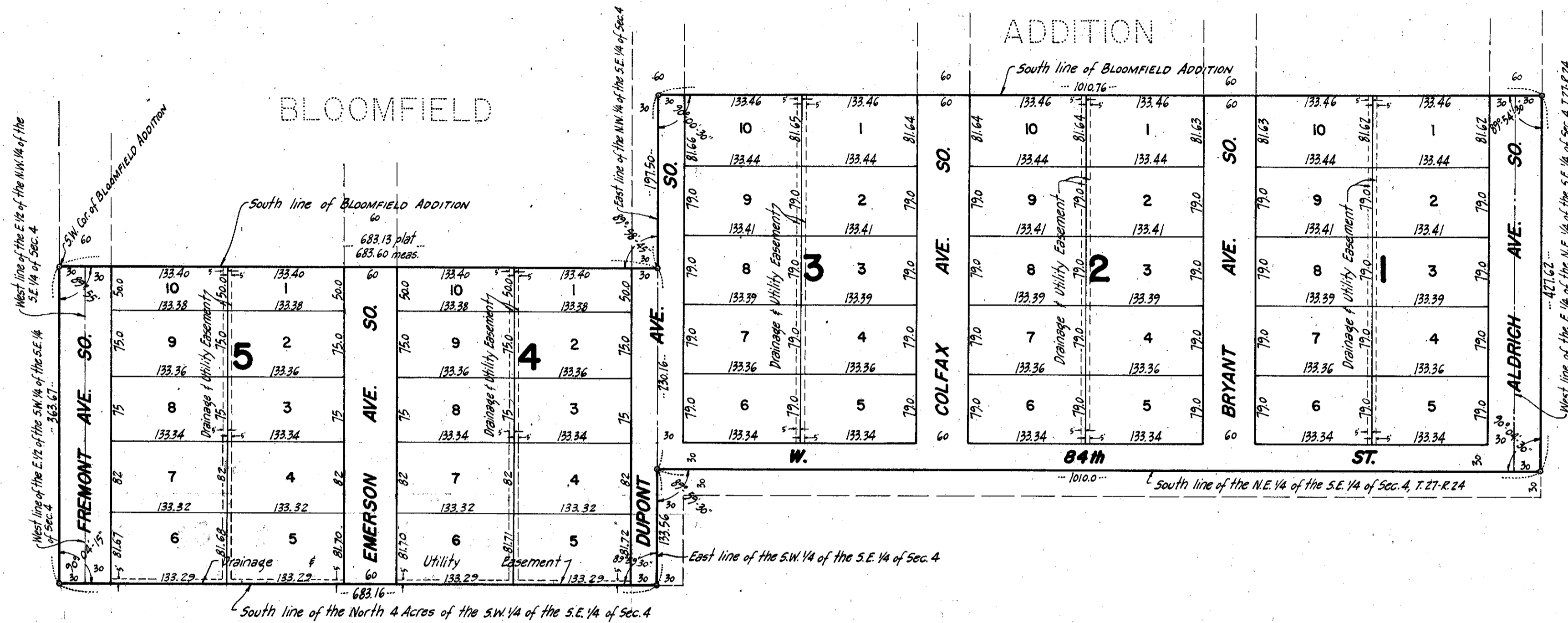

KNOW ALL MEN BY THESE PRESENTS: that Theo. R. Pahl and Irene Lorraine Pahl, his wife, owners and proprietors and E. J. Eliason and Alma Eliason, his wife, Contract for Deed purchasers of the following described property situate in the State of Minnesota and County of Hennepin to-wit:-

Beginning at a point on the South line of BLOOMFIELD ADDITION in Section 4, Township 27, Range 24, said point being 30.0 feet East of the West line of the East 1/4 of the Northeast 1/4 of the Southeast 1/4 of said Section 4; thence South on a line parallel with the West line of the East 1/4 of the Northeast 1/4 of said Section 4 to the South line of the Northeast 1/4 of the Southeast 1/4 of said Section 4; thence West along the South line of the Northeast 1/4 of the Southeast 1/4 of said Section 4 to the East line of the Southwest 1/4 of the Southeast 1/4 of said Section 4; thence South along the East line of the Southwest 1/4 of the Southeast 1/4 of said Section 4 to the South line of the North 4 Acres of the Southwest 1/4 of the Southeast 1/4 of said Section 4; thence West along the South line of the North 4 Acres of the Southwest 1/4 of the Southeast 1/4 of said Section 4 to a point 30.0 feet West of the West line of the East 1/2 of the Southwest 1/4 of the Southeast 1/4 of said Section 4; thence North along a line parallel with the West line of the East 1/2 of the Southwest 1/4 of the Southeast 1/4 of the Southeast 1/4 of said Section 4 and the West line of the East 1/2 of the Northeast 1/4 of the Southeast 1/4 of said Section 4 to the Southwest corner of BLOOMFIELD ADDITION; thence East along the South line of BLOOMFIELD ADDITION to the East line of the Northwest 1/4 of the Southeast 1/4 of said Section 4; thence North along the East line of the Northwest 1/4 of the Southeast 1/4 of said Section 4 to the South line of BLOOMFIELD ADDITION; thence East along the said South line of BLOOMFIELD ADDITION to the point of beginning.

Have caused the same to be surveyed and platted as BLOOMFIELD 2ND ADDITION and do hereby donate and dedicate to the public for public use forever, the street and avenues as shown on the annexed plat, and also subject to drainage and utility easements as shown on the annexed plat.
