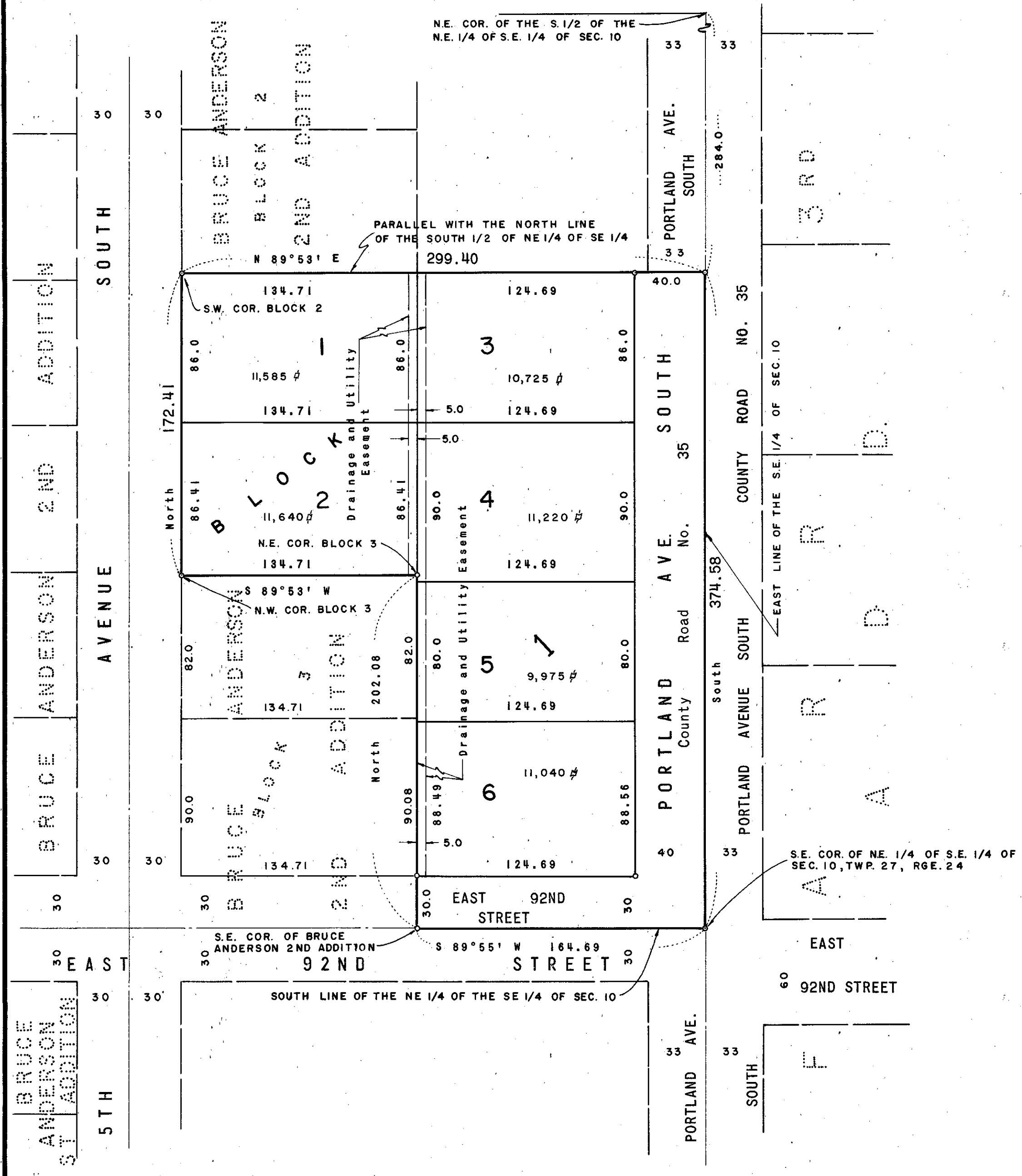


# BRUCE ANDERSON 3RD ADDITION

That part of the Northeast 1/4 of the Southeast 1/4 of Section 10, Township 27, Range 24, Hennepin County, Minnesota described as follows:  
Commencing at the Southeast corner of the Northeast 1/4 of the Southeast 1/4; thence Northerly along the East line thereof to a point 284 feet South from the Northeast corner of the South 1/2 of said Northeast 1/4 of the Southeast 1/4; thence Westerly parallel with the North line thereof to the Southwest corner of Block 2, BRUCE ANDERSON 2ND ADDITION, Hennepin County, Minnesota; thence Southerly to the Northwest corner of Block 3 of said BRUCE ANDERSON 2ND ADDITION; thence Easterly to the Northeast corner of said Block 3, BRUCE ANDERSON 2ND ADDITION; thence Southerly to the Southeast corner of said BRUCE ANDERSON 2ND ADDITION; thence Easterly to the point of beginning.
